I waited 2 days as per your instructions - which was all the instructions you gave - Your email did not mention as to how and in which way you would like me to conform to your rule. Since we were on email I presumed this would be the method and replied as such. Since you made no reply at all to any of my emails or attempted to contact me in any other way. I made the assumption it is in order. I then phone after waiting 2 days as per your instructions, for whatever reason you would have for making a rule like this, and now I am told after trying twice on Skype with a message asking you where you would like me to phone and phoning the home phone that I did not make arrangements. According to me the email is quite clear.

So now I would like to invite you to be more specific in your request. I would also like it if you can explain to me your reasons why you have this 2 day advance notification ruling. The children are certainly available. I can hear them. I do get the impression you trying to create difficulty by being small.
